- Ø Should part of the bus be damaged due to child(ren) actions the parent will be notified and liable for all damages.

Responsibilities of parents/guardians

- Ø Parents/guardians are responsible for transporting their children to and from authorised bus stops and their safety at the bus stop while waiting for the bus.
- Ø It is most important that parents waiting for bus passengers at a roadside bus stop should wait on the same side of the road as the bus to prevent accidents.
